#### Mission Peak Joins Lawsuit Against Homeless Ordinance

The Board of MPUUC held a special congregational meeting Tuesday evening, February 25, to discuss and vote on whether to join a class action lawsuit against the City of Fremont regarding its recently-passed ordinance 8.90, commonly known as the "Camping Ban" ordinance. This ordinance criminalizes sleeping in public places, and also criminalizes "aiding or abetting" a homeless person. If the ordinance goes into effect,

Mission Peak and other faith organizations would not be able to legally provide food, clothing or other help to unhoused people in the city. The congregation voted overwhelmingly to join the suit, with 34 yes votes, 1 no vote, 1 abstention. The Board notified lead counsel for the Fremont Homeless Union, Anthony Prince, of this decision on Tuesday night.




UUSJ Applauds UU Decision to Sue the Administration
We must defend the broad protections for performing religiously motivated actions

Washington, D.C. — The Unitarian Universalist

Association (UUA) joined more than two dozen Christian and Jewish religious denominations and associations on February 11 in filing a lawsuit against the Trump Administration's new policy that allows immigration raids, arrests, and other enforcement actions at houses of worship.

The new policy empowered enforcement actions that could interrupt religious services in furtherance of the Administration's mass deportation plans. The Trump Administration's rescission (memo) of the Department of Homeland Security (DHS) "sensitive locations" policy that had restricted Immigration and Customs Enforcement (ICE) from conducting immigration raids, arrests, and other enforcement actions at houses of worship is a violation of the broad protections for individuals performing religiously motivated actions.



Tell Your Legislators - The new administration has selected immigration for its assault on the Constitution, our norms, and our liberties.

ICE should not be allowed in our schools, hospitals, public demonstrations—and never at our houses of worship!

Early into his presidency, Trump ended several DEI initiatives in the federal government. The orders have caused PBS to close its DEI office, while major companies like Amazon. Target and Google are taking steps to dissolve DEI initiatives.

Congregations will be able to begin distributing member delegate credentials via the credentialing system in April.

The UUA Board of Trustees is working to engage delegates earlier than ever. Delegates can dive into the agenda, discuss amendments, and build consensus on the UUA discussion forum. Being prepared helps ensure a positive experience!

To support delegates, the Board will host online candidate forums and "What to Expect" webinars before GA. Business Mini-assemblies may take place in May or June. Election balloting will open on June 1.

#### **Board Briefs**

Board briefs from January 21 and 26, 2025 MPUUC Board meeting.

The Board met on January 21 and 26, 2025

#### Board Meeting 2025-01-21

- The Board approved a request to support/host 2 community groups with sharing of Ockerman space once a month (both are South Asian; 1)One group's focus is Mental Health, 2) Second group's focus is post-retirement socialization. MPUUC provides a "host' for building opening/closing.
- Rev. Ward used some of the Minister's Discretionary Fund to provide Holiday gifts for Staff, which they appreciated.



- Board Recognized the outstanding efforts of Ariel Smith-Iyer for 1) for the successful MLK Service event, which created community building as well as making resources for the unhoused; and 2) 10n Jan. 25, she organized a meeting at Cole Hall with some unhoused people, preparing them to be speakers at a future Service, hosting them for dinner.
- The TriCity Interfaith Council has accepted the MPUUC 2025 Love Hero Award which will be presented at the Service on February16.
- DeAnna Alm has accepted the invitation to Chair the 2025-206 Canvass, which will begin on March 2.
- A new Organizational Chart is being developed to streamline the operations at MPUUC. A diagram illustrating the new organization will be included in WOP and the subject of a Congregational Conversation after the Service Mar.2.
- The Leadership Committee will begin outreach for next year's Board positions.
- The Worship Hosts are reviewing how to cover all the tasks associated with inperson and virtual Services and meetings and events.

#### Special Board Meeting. 2025-01-26

- The Board reviewed a request from Fremont for Everyone, a local civic organization, to take a public position/make a statement regarding the proposed City of Fremont "Camping Ban" Ordinance that will make it illegal in Fremont to have camping "paraphernalia" and be outside on public or private property in possession of such property. The ordinance also contains an "aiding and abetting clause" which will make it a crime to give anyone such "paraphernalia" or assist them in any way to "camp" outdoors in Fremont.
- The Ordinance will be voted on a the City Council meeting on February 4 or February 11. The proposed 'statement' will be shared with other community organizations objecting to the proposed ordinance and with the media, as well as be sent to the Fremont City Council. The Board agreed to support the efforts to urge the City Council to "Vote No" on the proposed ordinance, because it is contrary to UU Principles Respecting the Inherent Worth and Dignity of every Person and criminalizes the status of being unhoused, or helping those residents in our community without shelter. The Board voted to craft a Statement, sign it as the Board, by President E. Schaefer; provide a copy to the entire Congregation, and seek the Congregation's support to oppose the proposed Ordinance and communicate directly with the City Council via letter/email/or attending the upcoming City Council meetings.

The next board meeting will be via Zoom on Tuesday, March 18, 2025 at 7 pm.
